# **RULES AND REGULATIONS**

# **Organizers**

The Municipality of Malesco and the "Ecomuseo Ed Leuzerie E Di Scherpelit" organize, from 27 July to 1 August 2020, the 21<sup>st</sup> edition of the International Short Film Festival "MALESCORTO" under the patronage of Regione Piemonte, Val Grande National Park, Ordine degli Architetti, Pianificatori, Paesaggisti e Conservatori of the provinces of Novara and Verbano Cusio Ossola, Associazione Musei d'Ossola and Centro Servizi per il Territorio Novara-VCO.

#### **Participants**

Participation in the competition is open to everyone, regardless of nationality or residence. Directors, production companies and educational institutions are eligible for submission. In the case of participants under 18 years of age, it is necessary to certify the consent of the parents or guardian.

# Requirements and conditions

There is no participation fee.

Incomplete or illegible files will not be taken into consideration.

Works in languages other than Italian must be subtitled in Italian. If subtitles in Italian are unavailable, subtitles in English, French or Spanish can be provided – separately from the film and in srt format. If subtitles are not provided as described herein, the work may be excluded from participation. If the quality of the files is considered unacceptable, no prize will be awarded to them.

#### **Duration**

Short films must not be longer than 20 minutes.

#### **Submission**

The short films, together with the participation form, must be submitted through online file-sharing services (WeTransfer, Dropbox, etc.) or by including links to video-sharing platforms such as Vimeo, YouTube, etc.

As for submissions made by schools, the applicant - unless otherwise specified by the participants - is generally identified with the relevant school institute. If, on the contrary, you wish to award the prize to a person other than the school (director or production company), must always and in any case fill in the appropriate form and have the authorization of the relevant school institute.

#### **Deadline for submissions**

The works submitted for the selection must be sent no later than 15<sup>th</sup> March 2020.

# Selection and jury

The short films will be examined by a jury composed of a minimum of three and a maximum of five people chosen by the Art Director of the Festival, Paolo Ramoni.

#### **Awards**

## **First Prize**

• Prize "MALESCORTO" 2019 (€ 1,000) - awarded to the director of the best short film.

# **Special Awards**

- Prize "ANIMATED SHORT FILM" 2020 (€ 200), awarded to the to the production of the best animated short film. This prize is sponsored by the Associazione Musei d'Ossola.
- PREMIO "MALESCHOOLS" 2020 (€ 300), awarded to the school institute and to those responsible for the production of the best short film made by schools.
- PREMIO "CINEMA & SUSTAINABILITY" 2020 (€ 300), awarded to the director of the best short film inspired by ecological issues. This award, created in collaboration with the Val Grande National Park, will reward the short films depicting the relationship between man and nature from an ecological perspective, the link between natural and cultural

capital, the relationship between man and pristine nature. There is no restriction on the geographical area.

- Prize "BROADCAST ARCHITECTURE" 2020 (€400), awarded to the production company of the short film set in the best indoor or outdoor location. This award is offered by the Ordine degli Architetti of the Provinces of Novara and VCO.
- AWARD "TERRITORIES" 2020 (€ 200), awarded to the director of the best short film shot in the territory of the Insubria Region, which includes:
  - Province of Verbano-Cusio-Ossola, Province of Varese, Canton Ticino, Province of Sondrio, Province of Como, Italian Grisons, Province of Lecco (with the exception of Valle San Martino), Province of Monza and Brianza, Metropolitan City of Milan, Province of Novara, part of the Province of Pavia (Pavese and Lomellina) and Province of Lodi.
- Prizes "VOLUNTEERING AND SOLIDARITY" 2020 (special section including the following prizes: €300 to the first place, €200 to the second place, €100 to the third place), awarded to the best short film inspired by the theme "volunteering and solidarity." Prizes will not be awarded cash, but in services from CST Centro Servizi of Novara and VCO quantified on the basis of the cash value of the prize itself and will be assigned exclusively to voluntary associations of Novara and VCO, and credited to CST; entries can be submitted both by voluntary associations as producers and by individuals involved in the production, who must allocate the prize to an association of their choice that meets the above requirements. These prizes will be assigned to voluntary associations only.

### **Special mentions:**

- BEST SHORT DOCUMENTARY 2020
- BEST SHORT FICTION 2020
- AUDIENCE AWARD 2020

The jury may also assign any honourable mentions in addition to the prizes and special mentions listed above.

Cash prizes will be paid exclusively to the relative assignee (indicated in the appropriate field of the registration form).

As for "Maleschools" section, it is necessary to send the dedicated form, properly filled in and signed.

# **Final provisions**

- The works sent will not be returned.
- The Festival Direction is not responsible for any theft, damage or loss of the material.

- The works that comply with the regulations, finalists and not, will be catalogued and will be part of the Festival archive that will remain available to schools and institutions that request them, for educational use only. The short films can be used for non-profit promotional evenings, on the initiative of the "Ecomuseo Ed Leuzerie e di Scherpelit", the Municipality of Malesco, the Val Grande Park and the Sesia Val Grande Geopark for the section "Cinema & Sustainability"; the CST for the section "Volunteering and solidarity". The works of the latter section will also be part of the archives of the Order of Architects, Planners, Landscape Architects and Conservators of the provinces of Novara and VCO for the section TransmittingArchitecture; the works of the latter section will also form part of the archives of the Ordine degli Architetti, Pianificatori, Paesaggisti e Conservatori of the Provinces of Novara and VCO for non-profit purposes only.
- Cash prizes will be paid by 31.12.2020.
- To receive the cash prizes, you must send us your complete bank details in order to make the payment.
- For all that is not expressly stated in the regulations, the opinion of the Festival Jury alone is valid.
- The event may be postponed or cancelled. In any of these cases, all the applicants will be notified.
- Public screenings will take place at the Cinema Comunale di Malesco (VB) from 28<sup>th</sup> to 31<sup>st</sup> July 2020, at 9 PM. The awards ceremony will be held on Saturday 1<sup>st</sup> August 2020 at 9 PM and will be followed by the screening of the winning short films.
